Pursuant to Section 412 of the District of Columbia
Self-Government and Governmental Reorganization Act (PL 93-198),
the Act, the Council of the District of Columbia adopted Bill
No. 1-310 on first and second readings July 20, 1976, and
September 15, 1976, respectively. Following the signature of the
Mayor on October 20, 1976, this legislation was assigned Act
No. 1-163, published in the January 7, 1977, edition of the
D.C. Register, and transmitted to both Houses of Congress for
a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired and, therefore, cites the following legislation as D. C. Law 1-100, effective APril 6, 1977.

## IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## April 6, 1977

To clarify the Affirmative Action in District Government Employment Act (D.C. Law 1-63).

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Affirmative Action Clarifying Act".

- Sec. 2. Section 9 of the Affirmative Action in the District Government Employment Act (D.C. Law 1-63) is amended as follows:
- (a) inserting immediately following "on a full-time basis, as", the word "non-uniformed";
  - (b) striking "and the Fire Department,";
- (c) striking ", and in the case of the person so detailed from the Metropolitan Police Department, such person shall not be a uniformed employee of the Metropolitan Police force"; and
- (d) adding the following sentences at the end thereof;
  "The Metropolitan Police Department and the Fire Department

are not authorized by this section to abolish, leave unfilled, or reduce the authority or duties of, any uniformed equal employment opportunity officer or specialist position. This section shall not be construed to affect any uniformed position in the District Government."

Sec. 3. This act shall take effect immediately following the period provided for Congressional review in section 602(c)(l) of the District of Columbia Self-Government and Governmental Reorganization Act.
