COUNCIL OF THE DISTRICT OF COLUMBIA NOTICE

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act (PL 93-198)(the Act), the Council of the District of Columbia adopted Bill No. 1-75 on first and second readings May 13, 1975, and May 27, 1975, respectively. Following the signature of the Mayor on June 13, 1975, this legislation was assigned Act No. 1-18 and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has expired and, therefore, cites the following legislation as D. C. Law No. 1-12, effective September 9, 1975.

D. C. Law No. 1-12

In the Council of the District of Columbia
September 9, 1975

To extend the effective dates of the District of Columbia Public Postsecondary Education Reorganization Act, and for other purposes.

Be it enacted by the Council of the District of Columbia, That this act may be cited as the "University of the District of Columbia Effective Date Act".

Sec. 2. It is the intent of the Council of the District of Columbia to approve the Congressional intent (expressed in section 102 of the District of Columbia Public Postsecondary Education Reorganization Act) to authorize a public land grant university through the reorganization of the existing institutions of public postsecondary education in the District of Columbia. It is the clear and specific intent of the Council that the University provide a range of programs and studies designed to reach the widest possible number of citizens and residents of the District of Columbia including career and technological education, liberal arts, sciences, teacher education, and graduate and postgraduate studies.

Sec. 3. The District of Columbia Public Postsecondary Education Reorganization Act is amended as follows:

(a) Section 201(b) of that Act is amended by (1) striking out "August 2, 1975" and inserting in lieu thereof

"August 2, 1976, and (2) striking out "June 30, 1976" and inserting in lieu thereof "June 30, 1977".

- (b) Section 201(c) of that Act is amended by striking out "September 2, 1975" and inserting in lieu thereof "September 2, 1976".
- (c) Section 207 of that Act is amended by striking out "June 30, 1977".
- (d) Section 407 of that Act is amended by striking out "July 1, 1975" each place it occurs in that section and inserting in lieu thereof in each such place "July 1, 1976".

Sec. 4. This act, including the amendments made by this act, shall be effective at the end of the 30 day period provided for Congressional review of acts of the Council of the District of Columbia in section 602(c) of the District of Columbia Self-Government and Governmental Reorganization Act.
