D.C. Law 1-128

"Nuisance Elimination Act of 1976".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, (PL 93-198) the Act, the Council of the District of Columbia adopted Bill No. 1-303 on first and second readings November 23, 1976 and December 7, 1976, respectively. Following expiration of the ten-day period provided the Mayor, in which no action was taken, pursuant to Section 404(e) of the Act, this legislation was assigned Act No. 1-222, published in the February 11, 1977, edition of the D.C. Register and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602 (c) (1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has expired and, therefore cites the following legislation as D.C. Law 1-128, effective April 23, 1977.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

April 23, 1977

To correct and abate nuisances on private property; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this Act may be cited as the "Nuisance Elimination Act of 1976".

Sec. 2. Section 2 of "An Act to cause the removal of weeds from lands in the city of Washington. District of Columbia, and for other purposes", approved March 1, 1899 (30 STAT. 959, D.C. Code, sec. 6-902) is amended

(a) By inserting the word "double" immediately preceding "the cost of such removal" and

(b) Striking "ten" and inserting in lieu thereof "twenty".

Sec. 3. The second sentence of Section 4 of "An Act to authorize the Commissioners of the District of Columbia to remove dangerous or unsafe buildings and parts thereof and for other purposes," approved March 1, 1899 (30 STAT. 923), as amended by Section 1 of "An Act to amend the Act of Congress approved March 1, 1899, entitled "An Act to

Authorize the Commissioners of the District of Columbia to remove dangerous or unsafe buildings and parts thereof, and for other purposes', and to further amend said Act by adding at the end thereof new sections numbered 5 and 6", approved April 5, 1935 (49 STAT. 107) (D.C. Code, sec. 5-504) is amended by adding the word "double" immediately before "the cost and expense".

Sec. 4. Section 5 of "An Act to amend the Act entitled, 'An Act to Authorize the Commissioners of the District of Columbia to remove dangerous or unsafe buildings and parts thereof, and for other purposes,' approved March 1, 1899, as amended", approved August 22, 1964 (78 STAT. 600) is amended by striking "one-half of 1 per centum for each month or part thereof" and inserting in lieu thereof "twenty per centum per annum" in the new section designated as "Section 6." (D.C. Code, sec. 5-506).

Sec. 5. This act shall become effective in the manner provided for acts of the Council of the District of Columbia in subsection (c)(1) of section 602 of the District of Columbia Self-Government and Governmental Reorganization Act (D.C. Code Supp. 1975, sec. 1-147 (c)(1)).
