Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, PL 93-198 (the Act), the Council of the District of Columbia adopted Bill No. 1-184 on October 7, 1975 and October 21, 1975, respectively. Following the Mayor's signature on November 7, 1975, this legislation was assigned Act no. 1-65, published in the November 28, 1975, edition of the <u>D.C. Register</u>, and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602(c) (1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has expired and, therefore, cites the following legislation as D.C. Law No. 1-45, effective February 17, 1976.

A bill to amend publication of sample ballots requirements; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Publication of Sample Ballots act of 1975".

- Sec. 2. Paragraph 3 of subsection (a) of Section 5 of the District of Columbia Elections Act, (D.C. Code, sec. 1-1105(a)(3)), is amended by deleting the period at the end of the subsection and by inserting the following at the end of the subsection: "... PROVIDED, however, nothing contained herein shall require the publication of a sample copy of the official ballots to be used in the Advisory Neighborhood Commissions' elections.".
- Sec. 3. This act shall become effective as provided by section 602(c) of the District of Columbia Self-Government and Governmental Reorganization Act.
