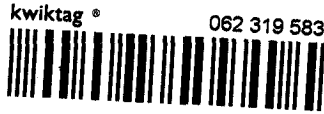

D.C. LAW 11- 21

**" Administration of Medication by Public School
Employees Amendment Act of 1995".**

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 11-45 on first and second readings, March 7, 1995 and April 4, 1995, respectively. Following the signature of the Mayor on April 17, 1995, pursuant to Section 404(e) of "the Act", and was assigned Act No. 11-40 and published in the April 28, 1995, edition of the D.C. Register (Vol. 42 page 1933) and transmitted to Congress on May 1, 1995 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 11-21, effective June 17, 1995.


To amend the Administration of Medication by Public School Employees Act of 1993 to repeal the 2-year sunset clause provision.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Administration of Medication by Public School Employees Amendment Act of 1995".


Sec. 2. Section 6(b) of the Administration of Medication by Public School Employees Amendment Act of 1993, effective November 20, 1993 (D.C. Law 10-55; 40 DCR 7219), is repealed.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in Section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Register, the District of Columbia Municipal Regulations.




