D.C. LAW 11- 25

**"Merit Personnel Early Out Retirement Revisions
Temporary Amendment Act of 1995".**

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 11-211 on first and second readings, April 4, 1995 and May 2, 1995, respectively. Following the signature of the Mayor on May 15, 1995, pursuant to Section 404(e) of "the Act", and was assigned Act No. 11-53 and published in the May 26, 1995, edition of the D.C. Register (Vol. 42 page 2563) and transmitted to Congress on May 19, 1995 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 11-25, effective July 14, 1995.

AN ACT

D.C. ACT 11-53

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAY 15, 1995

To amend, on a temporary basis, the District of Columbia Comprehensive Merit Personnel Act of 1978 to prohibit an individual who is under indictment for or who has been convicted of a felony related to his or her employment duties from receiving benefits under an Easy Out or Early Out Retirement Incentive Program.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Merit Personnel Early Out Retirement Revisions Temporary Amendment Act of 1995".

Sec. 2. Section 1104 of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code § 1-612.4) is amended by adding new subsections (g) and (h) to read as follows:

"(g) An employee who is under indictment for or who has been convicted of a felony related to his or her employment duties shall not be eligible for benefits under an Easy Out, Early Out, or similar Retirement Incentive program".


"(h) The term "felony", for the purposes of this section, shall be defined as a crime for which the penalty is at least imprisonment for 1 year or a fine or \$1,000."

Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire on the 225th day of its having taken effect or upon the effective date of the Merit Personnel Early Out Retirement Revisions Amendment Act of 1955, whichever occurs first.
