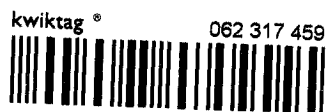

D.C. LAW 11-64

"Motor Vehicle Rental Company Amendment Act of 1995".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 11-162 on first and second readings, June 20, 1995 and July 11, 1995 respectively. The legislation was deemed approved without the signature of the Mayor on July 28, 1995, pursuant to Section 404(e) of "the Act", and was assigned Act No. 11-126 and published in the August 18, 1995, edition of the D.C. Register (Vol. 42 page 4322) and transmitted to Congress on August 2, 1995 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 11-64, effective October 21, 1995.

AN ACT

D.C. ACT 11-126

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 28, 1995

To amend the District of Columbia Human Rights Act to assure that motor vehicle rental companies are subject to the same prohibitions on discriminatory conduct as motor vehicle insurance companies.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Motor Vehicle Rental Company Amendment Act of 1995".

Sec. 2. Part H of the District of Columbia Human Rights Act, effective September 18, 1982 (D.C. Law 4-155; D.C. Code § 1-2533), is amended as follows:

(a) The title is amended to read as follows:

"Part H - Miscellaneous provisions."

(b) A new section 272 is added to read as follows:

"272. Motor vehicle rental companies.

"Notwithstanding any other provision of this act, it shall not be an unlawful practice for a motor vehicle rental company to fail or refuse to rent a motor vehicle, or to impose differential terms and conditions upon the rental of a motor vehicle, based on the age of any person, where such action is reasonably related to accident risk or threat to public safety."

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia
