D.C. LAW 12-146

"Library and Public Housing Drug Free Zone Amendment Act of 1998"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-10 on first and second readings, April 7, 1998 and May 5, 1998, respectively. Following the signature of the Mayor on May 20, 1998, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-358 and published in the June 19, 1998, edition of the D.C. Register (Vol. 45 page 3851) and transmitted to Congress on June 16, 1998 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-146, effective September 18, 1998.

To amend the District of Columbia Uniform Controlled Substances Act of 1981 to add public library and public housing as designated drug free zones.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Library and Public Housing Drug Free Zone Amendment Act of 1998".

Sec. 2. Section 407a of the District of Columbia Uniform Substances Act of 1981, effective March 21, 1995 (D.C. Law 10-229; D.C. Code § 33-547.1(a)), is amended by striking the phrase "or youth center" and inserting the phrase "youth center, public library, or in and around public housing, as defined in section 3(1) of the United States Housing Act of 1937, approved August 22, 1974 (88 Stat. 654; 42 U.S.C. § 1437a(b)), the development or administration of which is assisted by the United States Department of Housing and Urban Development" in its place.




