D.C. LAW 12-253

"Retired Police Officer Redeployment Amendment Act of 1998"

Pursuant to Section 412 of the District of Columbia Home Rule Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill 12-239 on first and second readings, December 1, 1998 and December 15, 1998, respectively. Following the signature of the Mayor on December 29, 1998, pursuant to Section 404(e) of "the Act", the bill became Act 12-601 and it was published in the February 19, 1999 edition of the D.C. Register (Vol. 46, page 1274). The Act was transmitted to Congress on February 10, 1999 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has expired, and the Act is now D.C. Law 12-253, effective April 20, 1999.

To amend the Retired Police Officer Redeployment Amendment Act of 1992, to authorize the Chief of the Metropolitan Police Department to rehire a retired member of the Metropolitan Police Department without liability for annuity offset or negative impact on the unfunded liability of the District of Columbia Police Officers and Firefighters Retirement Fund.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Retired Police Officer Redeployment Amendment Act of 1998".

Sec. 2. The Retired Police Officer Redeployment Amendment Act of 1992, effective September 29, 1992 (D.C. Law 9-163; D.C. Code § 4-618.1 *passim*), is amended as follows:

(a) Section 2 (D.C. Code § 4-618.1) is amended by adding a new subsection (g) to read as follows:

"(g) The provisions of this section shall apply to any police officer hired after September 29, 1992."

(b) Section 6(b) (D.C. Code § 4-618.1 note and § 4-629 note) is repealed.

Sec. 3. Fiscal impact statement.




Sec. 4. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in
