D. C. LAW 2-132

"Act to Amend the District of Columbia Public  
Postsecondary Education Reorganization Act"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 2-256, on first and second readings, July 25, 1978 and September 19, 1978 respectively. Following the signature of the Mayor on October 13, 1978, this legislation was assigned Act No. 2-279, published in the October 27, 1978, edition of the D.C. Register, (Vol. 23, page 3489) and transmitted to Congress on January 13, 1979 for a 30-day review, in accordance with Section 602 (c) (1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and, therefore, cites the following legislation as D.C. Law 2-132, effective March 3, 1979.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCTOBER 13, 1978

To amend the District of Columbia Public Postsecondary Education Reorganization Act concerning the quorum requirements of the Board of Trustees of the University of the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act be cited as the "Act to amend the District of Columbia Public Postsecondary Education Reorganization Act".

Sec. 2. The third sentence of section 401 of the District of Columbia Public Postsecondary Education Reorganization Act, approved October 25, 1974 (68 Stat. 1429; D.C. Code, sec. 31-1731), as amended, is further amended to read as follows:

"A total of eight (8) of the voting members of the Board of Trustees shall constitute a quorum for the transaction of business, except a lesser number may hold hearings."

Sec. 3. This act shall take effect as provided for acts of the Council of the District of Columbia in section 502(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act.
