
## NOTICE

D. C. LAW 2-142

"Confirmation Act of 1978"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 2-11, on first, and second readings, October 17, 1978 and October 31, 1978 respectively. Subsequent to the Mayor's disapproval on November 27, 1978, the Council re-enacted Act No. 2-312 on December 12, 1978, published in the January 5, 1979, edition of the D.C. Register, (Vol. 25 page 6112) and transmitted to Congress on January 18, 1979 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and, therefore, cites the following legislation as D.C. Law 2-142, effective March 3, 1979.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

December 12, 1978

To provide for the appointment of heads of subordinate agencies of the District of Columbia, by the Mayor, with the advice and consent of the Council.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,  
That this act may be cited as the "Confirmation Act of 1978".

Sec. 2. The Mayor may nominate persons to serve as subordinate agency heads in the Executive Service (as created by title X of the District of Columbia Government Comprehensive Merit Personnel Act of 1978), members of the Public Employee Relations Board and members of the Office of Employee Appeals, subject to the advice and consent of the Council of the District of Columbia, within ninety (90) days of the date such nominations are transmitted to the Chairman of the Council by the Mayor during which the Council is in continuous session. Failure of the Council to act during this time period shall cause the Mayoral nominee to be deemed confirmed. This provision shall not apply to the Secretary of the District of Columbia, the Executive

Secretary to the Board of Appeals and Review, and the Executive Director of the Commission on the Status of Women.

Sec. 3. This act shall become effective as provided for acts of the Council of the District of Columbia in subsection (c)(1) of section 602 of the District of Columbia Self-Government and Governmental Reorganization Act, or upon the effective date of Council Bill No. 2-10, District of Columbia Government Comprehensive Merit Personnel Act of 1978, whichever is later.
