

D.C LAW 2-52

"Increase Rate of Interest on Special
Assessments Act of 1977"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act (PL 93-198), the Act, the Council of the District of Columbia adopted Bill No. 2-185 on first and second readings October 11, 1977, and October 25, 1977, respectively. Following the signature of the Mayor on December 7, 1977, this legislation was assigned Act No. 2-113, published in the December 16, 1977, edition of the D.C. Register, and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired and, therefore, cites the following legislation as D. C. Law 2-52, effective March 16, 1978.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MARCH 15, 1978

To amend section 47-1105 of the District of Columbia Code to increase the rate of interest on assessments for the removal of nuisances.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Increase Rate of Interest on Special Assessments Act of 1977".

Sec. 2. Section 5 of the Act entitled "An Act Relating to the levying and collecting of taxes and assessments, and for other purposes", approved June 25, 1938 (52 Stat. 1200; D.C. Code, sec. 47-1105) is amended by striking the first sentence thereof and inserting in lieu thereof the following new sentence:

"All assessments authorized to be levied by the District of Columbia to reimburse it for money expended in the removal of nuisances shall bear interest at the rate of one and one-half per cent (1 1/2%) per month or part thereof from the date such assessment was levied."

Sec. 3. This act shall take effect as provided for acts of the Council of the District of Columbia according to the provisions of section 602(c)(1) of the "District of Columbia

Self-Government and Governmental Reorganization Act",
approved December 24, 1973 (87 Stat. 814; D.C. Code, sec. 1-
147(c)(1))-
