IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MARCH 15, 1976

To provide for the technical amendment of the Firearms Control Regulations Act of 1975, and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "Firearms Control Regulations Act Technical Amendments Act of 1977".

Sec. 2. The Firearms Control Regulations Act of 1975,

D.C. Law 1-65, is amended as follows:

(a) section 101 is amended by:

(1) striking "(1)" in subparagraph (B) of paragraph (3) and inserting "(A)" in lieu thereof; and

(2) striking "18" wherever it appears in subparagraph (15) and inserting "20" in lieu thereof;

(b) section 202 is amended as follows:

(1) by striking ";" and" at the end of subsection (d) and adding the following after the word act "Provided, that the provisions of this subsection shall not apply to any organization which has in its employ one (1) or more commissioned special police officers or other employees licensed to carry firearms, and which arms such employees with firearms during such employees' duty hours"; and

(2) by striking subsection "(e)" at the end thereof;

(c) section 203 is amended as follows:

(1) by striking "voluntary" in paragraph (6) of subsection (a) and inserting "voluntarily" in lieu thereof;

(2) by striking "for the same type of firearm; and" in subparagraph (10) of subsection (a) and inserting "for the same type of firearms: Provided, further, that this paragraph shall not apply with respect to any firearm re-registered pursuant to section 206(b) of this act; and"; and

(3) by striking everything after "Provided further, that" in subparagraph (11) of subsection (a) and inserting "this determination shall not be made with respect to persons applying to re-register any firearm pursuant to section 206(b) of this act." in lieu thereof;

(d) section 204 is amended by striking "203(a)" in subsection (a) and inserting "203" in lieu thereof;

(e) section 206 is amended as follows:

(1) by striking "and" in the heading and inserting "of" in lieu thereof; and

(2) by striking the "s" at the end of "certificates" in subsection (a);

(f) section 207 is amended as follows:

(1) by striking "upon" before the word "receipt" in the first sentence of subsection (a) and inserting "Upon" in lieu thereof; and

(2) by striking "names" in the second sentence of subsection (c) and inserting "named" in lieu thereof;

(g) section 210 is amended by striking "704" in subsection (c) and inserting "705" in lieu thereof;

(h) section 211 is amended by striking "703" and inserting "704" in lieu thereof;

(i) section 301 is amended by striking "705" in subsection (b) and inserting "706" in lieu thereof;

(j) section 406 is amended by striking "604" in paragraph (2) of subsection (c) and inserting "705" in lieu thereof;

(k) section 409 is amended by striking "703" and inserting "704" in lieu thereof;

(l) section 501 is amended as follows:

(1) by inserting "210(c)," before "502";

(2) by inserting a "," after "502"; and

(3) by striking "604" and inserting "705" in lieu thereof;

(m) section 502 is amended by striking "(f)" after the word "and" in subsection (d) and inserting "(e)" in lieu thereof;

(n) section 601 is amended as follows:

(1) by striking the "•" at the end of subsections "(a)", "(b)", and "(c)" and inserting a ";" in lieu thereof; and

(2) by inserting "or" after the ";" at the end of subsection "(c)"; and

(o) section 709 is amended by striking "605" in the second sentence and inserting "706" in lieu thereof.

Sec. 3. This act shall take effect as provided for acts of the Council of the District of Columbia pursuant to section 602(c)(1) of the "District of Columbia Self-Government and Governmental Reorganization Act", approved December 24, 1973 (87 Stat. 814; D.C. Code, sec. 1-147(c)(1)).
