
NOTICE

D. C. Law 2-72

"Licensing Periods Act of 1977"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 2-204, on first, and second readings January 10, 1978 and January 24, 1978, respectively. Following expiration of the ten-day review period provided the Mayor pursuant to Section 404 (e) of the Act, during which no action was taken, this legislation was assigned Act No. 2-148, published in the February 24, 1978, edition of the D. C. Register and transmitted to both Houses of Congress for a 30-day review in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired and therefore, cites the following legislation as D. C. Law 2-72, effective April 18, 1978.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

APRIL 13, 1973

To amend a section of the District of Columbia statutes to authorize the Mayor to establish variable licensing periods.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "Licensing Periods Act of 1977".

Sec. 2. Section 4 of the Act of July 14, 1955 (73 Stat. 534; D.C. Code, sec. 1-257) is amended by striking the word "Commissioners" and inserting in lieu thereof the words "Mayor of the District of Columbia".

Sec. 3. Section 3 of the "Variable Licensing Periods Act of 1977", effective October 26, 1977 (D.C. Law 2-27) is amended by deleting '5' and inserting '3' in lieu thereof.

Sec. 4. This act shall take effect as provided in section 502(c) of the District of Columbia Self-Government and Governmental Reorganization Act.
