
NOTICE

D. C. Law 2-75

"District of Columbia Youth Services Amendments
Act of 1977"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 2-119, on first and second readings January 24, 1978 and February 7, 1978, respectively. Following the signature of the Mayor on February 24, 1978, this legislation was assigned Act No. 2-153, published in the March 10, 1978, edition of the D. C. Register and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired and, therefore, cites the following legislation as D. C. Law 2-75, effective April 28, 1978.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

April 28, 1978

To amend provisions of the District of Columbia Youth Services Act of 1976.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Youth Services Amendments Act of 1977".

Sec. 2. The District of Columbia Youth Services Act of 1976 (D.C. Law 1-93), effective March 29, 1977, is amended as follows:

(a) by striking the last eleven (11) lines in subsection (c) of section 5 and inserting in lieu thereof the following:

(b) by striking the last nine (9) lines in subsection (a) of section 7 and inserting in lieu thereof the following:

1 Research Assistant	GS-9
1 Research Assistant	GS-7
3 Clerks	GS-4"; and

(c) by striking the last four (4) lines in subsection (b) of section 7 and inserting in lieu thereof the following:

"1 Recreation Specialist	GS-14
1 Program Analyst Officer	GS-12
1 Social Science Analyst	GS-11
2 Field Technical Assistants	GS-9
1 Secretary	GS-6
1 Clerk	GS-4".

Sec. 3. This act shall take effect according to the provisions of section 502(c) of the District of Columbia Self-Government and Governmental Reorganization Act.
