
NOTICE

D.C. Law 3-134

"Water and Sewer Service Rates Amendment Act of 1980".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-311 on first and second readings, July 29, 1980 and September 16, 1980, respectively. Following the signature of the Mayor on October 2, 1980, this legislation was assigned Act No. 3-255, published in the October 10, 1980 edition of the D.C. Register, (Vol. 27 page 4424). This act was originally transmitted to Congress on October 3, 1980, and resubmitted on January 14, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 3-134, effective March 5, 1981.

D.C. ACT 3-255

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 02 1980

To amend the schedule of water rates and the charges for sanitary sewer services, and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "Water and Sewer Service Rates Amendment Act of 1980".

Sec. 2. The third full sentence of section 1 of An Act making appropriations for the government of the District of Columbia and other activities chargeable in whole or in part against the revenues of such District for the fiscal year ending June 30, 1931, and for other purposes, approved July 3, 1930 (45 Stat. 985; D.C. Code, sec. 43-1520) is amended to read as follows:

"The rate for water furnished all premises through metered services shall be 45 cents for each one hundred cubic feet of water used."

Sec. 3. Section 701(b) of the Revenue Act of 1975, approved October 21, 1975 (D.C. Law 1-23; D.C. Code, sec. 43-1605a) is amended as follows:

(a) Paragraphs (1) and (2) are repealed and the following new paragraph is inserted to read as follows:

D.C. Code, sec. 43-1605a

"(1) The charge for sanitary sewer service furnished all premises in the District of Columbia shall be 57.7 cents for each one hundred cubic feet of water and shall be collected in the same manner and at the same time as water charges are collected." in lieu thereof.

(b) Paragraphs (3) and (4) are redesignated as paragraphs (2) and (3), respectively.


Sec. 4. The water and sanitary sewer service rates set by this act shall apply to water and sewer service provided on and after October 1, 1980, or on and after the date on which the Mayor of the District of Columbia certifies to the Council of the District of Columbia that the water and sewer service billing schedule is current, whichever date occurs last.



Sec. 5. This act shall take effect after a thirty (30) day period of Congressional review
