Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198,
"the Act", the Council of the District of Columbia adopted Bill
No. 3-301 on first and second readings, July 29, 1980 and
September 16, 1980, respectively. Following the signature of the
Mayor on October 2, 1980, this legislation was assigned Act No.
3-260, published in the October 17, 1980 edition of the D.C.
Register, (Vol. 27 page 4555). This act was originally
transmitted to Congress on October 3, 1980, and resubmitted
on January 14, 1981 for a 30-day review, in accordance with
Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 3-139, effective March 5, 1981.

- (a) subsection (c) (D.C. Code, sec. 47-2331(c)) is amended to read as follows:
- *(c) There is hereby imposed for the privilege of operating venicles for nire+ naving a

seating capacity of eight passengers or more. in addition to the driver or operator, other than those licensed under paragraph (a) of this section in the District of Columbia, a license tax of \$150 per annum or \$10 per day at the option of the operator. The license issued pursuant to this subsection shall be transferable between vehicles operated under the same ownership, management, operation, or control. No such vehicle shall be operated unless there shall be conspicuously displayed thereon a license issued under the terms of this paragraph. Annual licenses issued under this paragraph shall date from April 1 of each year, but may be issued on or after March 1 of such year.*;

- (b) subsection (q) (0.5. Code. sec. 47-2331(q)) is amended to read as follows:
- "(q) Nothing in this paragraph shall be construed to require the procuring of a license, or the payment of a tax, with respect to a vehicle bund or operated by a state or local government or a subdivision or instrumentality thereof and is being used to transport school children, their teachers, or escorts to the District of Columbia

from the State in which their school is located."; and

(c) subsection (n) (D.C. Code, sec. 47-2331(h)) is repealed.

Sec. 3. This act small take effect after a thirty (30) day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the vato) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24- 1973 (87 Stat. 313; D.C. Code. sec. 1-147(c)(1)).
