

D.C. Law 3-147

"Firearms Penalty Act of 1980".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-325 on first and second readings, September 30, 1980 and October 14, 1980, respectively. Following the signature of the Mayor on October 29, 1980, this legislation was assigned Act No. 3-272, published in the November 7, 1980 edition of the D.C. Register, (Vol. 27 page 4882). This act was originally transmitted to Congress on November 7, 1980, and resubmitted on January 14, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 3-147, effective March 5, 1981.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 29 1980

To amend the Firearms Control Regulation Act of 1975 to increase the criminal penalties thereunder, and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Firearms Penalty Act of 1980".

Sec. 2. Section 70b of the Firearms Control Regulations Act of 1975, effective September 24, 1975 (D.C. Law 1-15; D.C. Code, sec. 6-187b) is amended to read as follows:


"Sec. 70b. Penalties. Any person who violates any provision of this act shall upon conviction be fined not more than \$1,000 or be imprisoned for not more than one (1) year, or both."



Sec. 3. This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia
