
NOTICE

D.C. Law 3-150

"District of Columbia Board of Education and University of the District of Columbia Compensation System Establishment Act of 1980".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-349 on first and second readings, September 30, 1980 and October 14, 1980, respectively. Following the signature of the Mayor on October 29, 1980, this legislation was assigned Act No. 3-275, published in the November 7, 1980 edition of the D.C. Register, (Vol. 27 page 4900). This act was originally transmitted to Congress on November 7, 1980, and resubmitted on January 14, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 3-150, effective March 5, 1981.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 29 1980

To adopt the basic compensation system for the District of Columbia Board of Education and the University of the District of Columbia; to amend the provisions of the District of Columbia Government Comprehensive Merit Personnel Act of 1978 relating to compensation; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "District of Columbia Board of Education and University of the District of Columbia Compensation System Establishment Act of 1980".

Sec. 2. Pursuant to section 1111(n) of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code, sec. 1-341.11(h)), the Council of the District of Columbia adopts as the basic compensation system for the Educational Services of the District of Columbia Board of Education and the University of

the District of Columbia, the compensation system and pay schedules which were transmitted to the Council of the District of Columbia by the Mayor of the District of Columbia on October 17, 1979.

Sec. 3. Section 1111 the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1978 (D.C. Law 2-139; D.C. Code, sec. 1-341.11) is amended as follows:

(a) Subsection (c) is amended by (1) deleting the phrase "this classification" and inserting the phrase "their classification" in lieu thereof; and (2) striking the word "system" and inserting the word "systems" in lieu thereof.

(b) Subsection (e) is amended by (1) striking the word "comprehensive" and insert the word "new" in lieu thereof; (2) by striking the word "system" and inserting the word "systems" in lieu thereof; and (3) striking the word "shall" and inserting the word "may" in lieu thereof.

(c) Subsection (f) is amended by (1) striking the word "comprehensive" and inserting the word "new" in lieu thereof; and (2) striking the word "system" and inserting the word "systems" in lieu thereof.

(d) Subsection (q) is amended to read as follows:

"Each Board shall submit to the Mayor its proposed new compensation systems developed pursuant to the provisions of subsections (d) and (e) of this section, within twenty (20) days of the submission of the compensation proposals by the respective Boards to the Mayor, the Mayor shall transmit the new compensation systems to the Council in the form of a proposed act. The Mayor shall append a statement of his or her proposed adjustments to the new compensation systems as submitted by each Board including detailed reasons for his or her support or opposition. Until such time as the new compensation systems are approved, the compensation systems, including the salary and pay schedules in effect on December 31, 1979, shall continue in effect: PROVIDED, That pay adjustments shall be made in accordance

with the policy stated in section 1103 of the title."

(e) Subsection (h) is amended by striking the word "system" and inserting the word "systems" in lieu thereof.

(f) Subsection (i)(1) is amended by striking the phrase "the basic compensation system" and the phrase "its basic compensation systems in lieu thereof."


(g) Subsection (i)(4) is deleted in its entirety.


(h) Subsection (i)(5) is amended to read as follows:

"Beginning with the year commencing January 1, 1980, each Board shall submit to the Council by no later than October 1 of each year all proposed pay changes and adjustments and other proposed changes to the compensation systems if any for approval under the provisions of this section."

Sec. 4. This act shall take effect after a thirty (30) day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the

District of Columbia to override the veto) as provided in section 502(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-147(c)(1)).
