

D.C. Law 3-166

"Day Care Policy Act Amendment Act of 1980".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-381 on first and second readings, October 28, 1980 and November 12, 1980, respectively. Following the signature of the Mayor on November 25, 1980, this legislation was assigned Act No. 3-297, published in the December 5, 1980 edition of the D.C. Register, (Vol. 27 page 5355). This act was originally transmitted to Congress on December 4, 1980, and resubmitted on January 14, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 3-166, effective March 5, 1981.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOV 25 1980

to amend the Day Care Policy Act with regard to income eligibility.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

that this act may be cited as the "Day Care Policy Act Amendment Act of 1980".

Sec. 2. Section 6 of the Day Care Policy Act of 1979, effective September 19, 1979 (D.C. Law 3-166; D.C. Code, sec. 3-305) is amended as follows:

(a) Subsection (b) is amended by striking the figure "fifty (50)" and inserting the figure "sixty-two (52)" in lieu thereof.

(b) Subsection (c) is amended by (1) striking the figure "eighty-five (85)" and inserting the figure "one hundred six (106)" in lieu thereof.

(c) Subsection (d) is amended (1) by striking the figure "fifty (50)" and inserting the figure "sixty-two (52)" in lieu thereof; and (2) by

striking the figure "eighty-five (85)" and inserting the figure "one hundred six (106)" in lieu thereof.

(d) The chart in subsection (c) is amended as follows:

(1) by striking the figure "50%" and inserting the figure "52%" in lieu thereof;

(2) by striking the figure "85%" and inserting the figure "105%" in lieu thereof;

(3) by striking the figure "57%" and inserting the figure "70%" in lieu thereof;

(4) by striking the figure "64%" and inserting the figure "79%" in lieu thereof;


(5) by striking the figure "71%" and inserting the figure "88%" in lieu thereof; and

(6) by striking the figure "73%" and inserting the figure "97%" in lieu thereof.


Sec. 3. This act shall take effect after a thirty (30) day period of Congressional review following approval by the Mayor (or in the event veto by the Mayor, action by the Council of the City of Columbia to override the veto) as provided in section 502(c)(1) of the District of
