#### D. C. LAW 3-49

"Uniform Commercial Code-Bulk Transfers Amendment Act of 1979"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-104, on first and second readings, November 6, 1979 and November 20, 1979 respectively. Following the signature of the Mayor on December 12, 1979, this legislation was assigned Act No. 3-135, published in the December 21, 1979, edition of the D.C. Register, (Vol. 26 page 2731) and transmitted to Congress on December 21, 1979 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and, therefore, cites this enactment as D.C. Law 3-49 effective February 7, 1980.

# D.C. ACT 3 - 135

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## DEC 12 1979

To amend Article 6 of the Uniform Commercial Code to include certain additional establishments within the provisions pertaining to bulk transfers, and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "Uniform Commercial Code
Bulk Transfers Amendment Act of 1979".

- Sec. 2. Section 28:6-102(3) of the District of Columbia Code is amended to read as follows:
  - "(3) The enterprises subject to this article are:
     "(a) all of those whose principal business is
     the sale of merchandise from stock, including
     those who manufacture what they sell; and
     "(b) all restaurants (as defined in section
     3(n) of the District of Columbia Alcoholic
     Beverage Control Act, approved January 24,
     1934 (48 Stat. 319; D.C. Code, sec. 25 103(n)), cafes, bakeries, taverns (as defined
     in section 3(q) of the District of Columbia

Alcoholic Beverage Control Act, approved

January 24, 1934 (48 Stat. 319; D.C. Code,

sec. 25-103(q)) and like establishments where

food or drink (including, but not limited to,

spiritous liquors, malt liquors, beer and

wine) is furnished for consideration.

Sec. 3. This act shall take effect as provided for acts of the Council of the District of Columbia in section 602(c)(l) of the District of Columbia Self-Government and Governmental Reorganization Act.
