D.C. LAW 4-111

"Anti-Sex-Discriminatory Language Act and Uniform  
Disposition of Unclaimed Property Act of 1980  
Amendments Act of 1982".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-374 on first and second readings, March 9, 1982 and March 23, 1982, respectively. Following the signature of the Mayor on April 12, 1982, this legislation was assigned Act No. 4-174, published in the April 23, 1982 edition of the D.C. Register, (Vol. 29 page 1684) and transmitted to Congress on April 20, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-111, effective June 4, 1982.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

APR 12 1982

To amend the Anti-Sex-Discriminatory Language Act to revise the gender rule of construction; to make technical numbering amendments to the Uniform Disposition of Unclaimed Property Act of 1980; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Anti-Sex-Discriminatory Language Act and Uniform Disposition of Unclaimed Property Act of 1980 Amendments Act of 1982".

Sec. 2. The Anti-Sex-Discriminatory Language Act, effective October 1, 1976 (D.C. Law 1-87; [1976] D.C. Stat. 194) is amended by adding the following section 44 thereto:

"Sec. 44. (a) The second paragraph of section 2 of the Act of March 3, 1901 (D.C. Code, sec. 49-203) is amended to read as follows:

'Unless the Council of the District of Columbia specifically provides that this section shall be inapplicable to a particular act or section, all the words thereof importing one gender include and apply to the other gender as well.'

Sec. 3. The Uniform Disposition of Unclaimed Property Act of 1980, effective March 5, 1981 (D.C. Law 3-160; D.C. Code, sec. 42-201 et seq.) is amended as follows:

(a) Section 104 (D.C. Code, sec. 42-204) is amended by striking the phrase "sections 102 and 105 through 114" and inserting the phrase "sections 103 and 105 through 116" in lieu thereof.




(b) Section 130 (D.C. Code, sec. 42-230) is amended by striking the phrase "section 131" and inserting the phrase "section 132" in lieu thereof.

Sec. 4. This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved

December 24, 1973 (87 Stat. 813; D.C. Code, sec.
