D.C. LAW 4-121

"District of Columbia Flag Display Act of 1982".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-365 on first and second readings, April 6, 1982 and April 27, 1982, respectively. Following the Signature of the Mayor on May 11, 1982, this legislation was assigned Act No. 4-184, published in the May 21, 1982 edition of the <u>D.C. Register</u>, (Vol. 29 page 2072) and transmitted to Congress on May 17, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-121, effective July 1, 1982.

D.C. ACT 4 - 184

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAY 1 1 1982

To require the display of the District of Columbia flag at all times and places in the District that the display of the United States flag is required by federal law.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "District of Columbia
Flag Display Act of 1982".

Sec. 2. Findings.

The Council of the District of Columbia finds that:

- (a) Section 2 of a Joint Resolution to codify and emphasize existing rules and customs pertaining to the display and use of the flag of the United States of America, approved June 22, 1942 (56 Stat. 379; 36 U.S.C. sec. 174) addresses the method, time, and places for the display of the United States flag:
- (1) The flag should be hoisted briskly and lowered ceremoniously.
- (2) It is the universal custom to display the flag only from sunrise to sunset on buildings and stationary flagstaffs in the open. When a patriotic

D.C.Code, sec. 1-121 (1981 ed.) effect is desired, however, the flag may be displayed twenty-four (24) hours a day if properly illuminated during the hours of darkness.

- (3) The flag should not be displayed on days when the weather is inclement, except when an all-weather flag is displayed.
- (4) The flag should be displayed on all days, especially on those days designated as federal and state holidays.
- (5) The flag should be displayed daily on or near the main administration building of every public institution.
- (6) The flag should be displayed in or near every polling place on election days.
- (7) The flag should be displayed during school days in or near every schoolhouse.
- (b) The display of the District of Columbia flag will inculcate a spirit of patriotism in our citizens.
- Sec. 3. The flag of the District of Columbia shall be displayed in the same manner, at the same time, and on the same occasions as the flag of the United States is displayed in the District of Columbia pursuant to and consistent with federal law.
- Sec. 4. Wherever practicable, the District of Columbia flag shall be flown on the same staff as the United States flag.

D.C.Code, sec. 1-124 (1981 ed.) shall be displayed inside all public buildings whenever and wherever the flag of the United States is displayed.

Sec. 6. The Department of Finance and Revenue shall give notice of the provisions of this act in each real property tax bill sent to commercial property owners in the next mailing immediately following the effective date of this act.

Sec. 7. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
