

D.C. LAW 4-163

"Day Care Policy Act of 1979 Amendment Act of 1982".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-457 on first and second readings, July 6, 1982, and July 20, 1982, respectively. Following the signature of the Mayor on July 29, 1982, this legislation was assigned Act No. 4-237, published in the September 10, 1982, edition of the D.C. Register, (Vol. 29 page 3974) and transmitted to Congress on August 2, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-163, effective September 29, 1982.

D.C. ACT 4-237

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUL 29 1982

To amend policies regarding eligibility for subsidized day care services in the event of parent loss of employment, and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Day Care Policy Act of 1979 Amendment Act of 1982".

Sec. 2. The Day Care Policy Act of 1979, effective September 19, 1979 (D.C. Law 3-16; D.C. Code, sec. 3-301 et seq.) is amended as follows:

(a) Section 2 (D.C. Code, sec. 3-301) is amended by adding a new subsection (f) to read as follows:

"(f) The term 'termination of employment' means loss of employment by a parent resulting from a reduction in force, or in the case of private employment, a layoff or reduction in personnel due to budgetary constraints of the employer."

(b) Section 5 (D.C. Code, sec. 3-304) is amended by adding new subsection (g) to read as follows:

"(g) Children of working parents whose employment has been terminated shall have their eligibility for day care services continued, at no




cost to the parent, for three (3) months following the effective date of such termination of employment."

(c) Section 6(c) (D.C Code, sec. 3-305(3)) is amended by striking the period at the end thereof and by inserting the phrase ", except in the case of children whose parents' gross income has been determined by the Department to have increased, up to a maximum of one hundred fifteen per cent (115%) of the specified median income, shall have their eligibility for subsidized day care services continued at the current payment level for three (3) months following the effective date of such determination." in lieu thereof.

Sec. 3. This act shall take effect after a 30-day period of Congressional review, following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
