### D.C. LAW 4-198

"State Revenue Officers Registration Improvements Act of 1982".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-493 on first and second readings, November 16, 1982, and December 14, 1982, respectively. Following the signature of the Mayor on December 28, 1982, this legislation was assigned Act No. 4-282, published in the January 14, 1983, edition of the D.C. Register, (Vol. 30 page 117) and transmitted to Congress on January 7, 1983 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-198, effective March 10, 1983.

# D.C. ACT 4 -282

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# DEC 28 1982

To amend the State Revenue Officers Registration Act of 1978 to provide for the personal registration of out-of-state revenue officers; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "State Revenue Officers
Registration Improvements Act of 1982".

Sec. 2. Section 3(a)(2) of the State Revenue Officers Registration Act of 1978, effective September 9, 1978 (D.C. Law 2-102; D.C. Code, sec. 4-1002(a)(2)) is amended by striking the phrase "or in writing".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code,
