"District of Columbia Public Assistance Act of 1982 Personal Needs Allowance Amendments Act of 1982".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-515 on first and second readings, November 16, 1982, and December 14, 1982, respectively. Following the signature of the Mayor on December 28, 1982, this legislation was assigned Act No. 4-292, published in the January 14, 1983, edition of the D.C. Register, (Vol. 30 page 202) and transmitted to Congress on January 7, 1983 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-208, effective March 10, 1983.

To amend the District of Columbia Public Assistance Act of 1982 to increase the personal needs allowance for persons living in Community Residential Facilities and to permit persons not living independently to be eligible for the District supplement to their Supplemental Security Income benefits.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "District of Columbia
Public Assistance Act of 1982 Personal Needs Allowance
Amendments Act of 1982".

Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat 813; D.C. Code, sec. 1-233(c)(1)).
