"Council of the District of Columbia Official Seal Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-20 on first and second readings, February 24, 1981 and March 10, 1981, respectively. Following the signature of the Mayor on March 20, 1981, this legislation was assigned Act No. 4-13, published in the April 3, 1981 edition of the D.C. Register, (Vol. 28 page 1422) and transmitted to Congress on March 27, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-3, effective May 22, 1981.

To authorize the Council of the District of Columbia to adopt an official seal.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA.

That this act may be cited as the "Council of the District of Columbia Official Seal Act of 1981".

Sec. 2. The Council of the District of Columbia shall by resolution, adopt an official seal, which shall be judicially noted.

Sec. 3. This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 502(c)(l) of the District of Columbia Self-Government and Governmental

Reorganization Act. approved December 24. 1973 (87 Stat. 313; D.C. Code. sec. 1-147(c)(1)).
