D.C. LAW 4-39

"Good Faith Donor and Donee Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-4 on first and second readings, June 16, 1981 and June 30, 1981, respectively. Following the signature of the Mayor on July 20, 1981, this legislation was assigned Act No. 4-66, published in the July 31, 1981 edition of the D.C. Register, (Vol. 28 page 3391) and transmitted to Congress on July 23, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-39, effective October 8, 1981.

To limit the liability of certain persons and organizations who donate and distribute food free of charge or at a nominal cost.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA. That this act may be cited as the "Good Faith Donor and Donee Act of 1981".

Sec. 2. (a) All other provisions of law notwithstanding, a good faith donor of food which is not known or believed to be unfit for human consumption, as defined in section 8-6:102 of Title 8 of the District of District of Columbia Health Regulations (published as title 8 of the District of Columbia Regulations; 1962 Revision, as amended) ("Health Regulations"), at the time it is donated to a bonafide charitable or not for profit organization shall not be subject to criminal or civil liability arising from an injury or death due to the condition of such food unless

Sec. 3. Nothing in this act shall restrict the authority of the Mayor of the District of Columbia to inspect, condemn, denature, destroy, seize, or remove food for human consumption pursuant to An Act To prevent the sale of unwholesome food in the District of Columbia, approved December 16, 1941 (55 Stat. 807; D.C. Code, Sec. 22-3418).

Code, sec. 1-147(c)(1)).
