D.C. LAW 4-46

"Official Purposes Funds Amendment Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-202 on first, amended first and second readings, June 16, 1981, June 30, 1981 and July 14, 1981, respectively. Following the signature of the Mayor on August 6, 1981, this legislation was assigned Act No. 4-81, published in the October 2, 1981 edition of the D.C. Register, (Vol. 28 page 4271) and transmitted to Congress on September 9, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-46, effective October 24, 1981.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

AUG 06 1981

To authorize the expenditure of funds by the District of Columbia Library for official purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "Official Purposes Funds Amendment Act of 1981".

Sec. 2. The first sentence of section 26 of an Act To authorize certain programs and activities of the government of the District of Columbia, and for other purposes, approved October 26, 1973 (87 Stat. 509; D.C. Code, secs. 1-262a & 31-1122) is amended to read as follows:


"The Mayor of the District of Columbia, the Chairman and Members of the Council of the District of Columbia, the Chief Judge of the District of Columbia Court of Appeals, the Chief Judge of the Superior Court of the District of Columbia, the Executive Officer of the District of Columbia Court System, the Superintendent of Schools, the Director of the District of Columbia

Public Library, and the Chief Executive Officer of the University of the District of Columbia are authorized to provide for the expenditure, within the limits of specified annual appropriation, of funds for appropriate purposes related to their official capacity as they may respectively deem necessary."

Sec. 3. This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-147(c)(1)).
