D.C. LAW 4-81

"Newspaper Publication Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-323 on first and second readings, November 10, 1981 and November 24, 1981, respectively. Following the signature of the Mayor on December 21, 1981, this legislation was assigned Act No. 4-135, published in the January 8, 1982 edition of the D.C. Register, (Vol. 29 page 156) and transmitted to Congress on January 11, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-81, effective March 16, 1982.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DEC 21 1981

To amend the laws of the District of Columbia concerning the publication of notices by the District of Columbia; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Newspaper Publication Act of 1981".

Sec. 2. Section 1 of An Act to provide for semi-annual statements by foreign corporations doing business in the District of Columbia, approved July 29, 1892 (27 Stat. 325; D.C. Code, sec. 29-105) is amended by striking the phrase "two daily newspapers printed in the District of Columbia" and inserting the phrase "two general circulation newspapers, published in the District, once every two weeks or more frequently" in lieu thereof.

Code, sec. 47-1301) is amended by striking the phrases "the regular issue of three daily newspapers published in said District", and "two major daily newspapers published in the District" wherever they occur, and inserting the phrase "two general circulation newspapers, published in the District, once every two weeks or more frequently" in lieu thereof respectively.

Sec. 6. Notwithstanding any other provisions of law, any other requirement that the District of Columbia publish notices in two (2) daily newspapers shall be satisfied by publication in at least two (2) general circulation newspapers, published in the District of Columbia, once every two weeks or more frequently.

Sec. 7. This act shall apply to any requirement that the District of Columbia publish notices on or after

This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1937 (87 Stat. 813; D.C. Code, sec. 1-233 (c)(1)).
