D.C. LAW 4-93

"District of Columbia Motor Vehicle Definition Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-312 on first and second readings, December 8, 1981 and January 12, 1982, respectively. Following the signature of the Mayor on February 9, 1982, this legislation was assigned Act No. 4-151, published in the February 19, 1982 edition of the D.C. Register, (Vol. 29 page 749) and transmitted to Congress on February 16, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-93, effective April 3, 1982.

FER 9 - 382

To clarify the definitions of passenger vehicle and commercial vehicle in Title 18 of the District of Columbia Municipal Regulations; to provide for the registration of small pick-up trucks and vans as passenger vehicles; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Motor Vehicle Definition Act of 1981*.

Sec. 2. The following undesignated paragraphs of section 9901 of title 18 of the District of Columbia Municipal Regulations are amended to read as follows:

*COMMERCIAL VEHICLE - Any vehicle, with more than three (3) wheels, designed for transporting freight, merchandise, or other commercial loads or property; and weighing more than six thousand (6,000) pounds or greater than twenty-two (22) feet in length, shall be classified as a commercial vehicle; and any vehicle

(6,000) pounds or less, not exceeding twenty-two (22) feet in length, and used or maintained for transporting

with more than three (3) wheels, weighing six thousand

freight, merchandise, or other commercial loads or

property shall be classified as a commercial vehicle.".

CODIFICATION D.C. Municip Regulations (DOMR)

"PASSENGER VEHICLE - Any vehicle, other than a commercial vehicle, with more than 3 wheels, designed, used, or maintained for passenger, recreational, or other noncommercial purposes except such vehicles used for livery, rental, sightseeing, or taxi purposes.".

Sec. 3. The paragraph designated as "Class B:" in section 3(b) of Title IV of the District of Columbia Revenue Act of 1937, approved August 17, 1937 (50 Stat. 681; D.C. Code, sec. 40-104(b)(2)) is amended by deleting the word "truck" and inserting the phrase "commercial vehicle" in lieu thereof.

Sec. 4. This act shall take effect after a thirty (30)—day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233 (c)(1)).
