D.C. LAW 4-99

"Life Insurance Act Amendment of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-325 on first and second readings, January 26, 1982 and February 9, 1982, respectively. Following the signature of the Mayor on February 22, 1982, this legislation was assigned Act No. 4-157, published in the March 5, 1982 edition of the D.C. Register, (Vol. 29 page 967) and transmitted to Congress on February 23, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-99, effective April 6, 1982.

To amend the Life Insurance Act to authorize life insurance companies to make home mortgage loans to their officers when such officers are required to relocate in connection with their employment.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Life Insurance Act
Amendment of 1981".

Sec. 2. Section 30 of Chapter III of the Life
Insurance Act, approved June 19, 1934 (48 Stat. 1151;
D.C. Code, sec. 35-630) is amended by striking the
phrase "a director not in excess of the net value
thereof." and inserting the phrase "a director or
officer not in excess of the net value thereof or
prevent any company in connection with the relocation
of the place of employment of an officer, including any
relocation in connection with the initial employment of
such officer from; (1) making (or such officer from
accepting therefrom) a mortgage loan to such officer on
real property owned by such officer which is to serve
as such officer's residence; or (2) acquiring (or such
officer from selling thereto) at not more than the fair
market value thereof, the residence of such officer."

Sec. 3. This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
