"District of Columbia Municipal Regulations Publication Temporary Act of 1983".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-150 on first and second readings, March 15, 1983 and March 29, 1983, respectively. Following the signature of the Mayor on April 6, 1983, this legislation was assigned Act No. 5-24, published in the April 22, 1983 edition of the D.C. Register, (Vol. 30 page 1793) and transmitted to Congress April 8, 1983 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.S. Law 5-10, effective May 20, 1983.

To extend the legal effectiveness of documents not published in the District of Columbia Municipal Regulations.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "District of Columbia

Municipal Regulations Publication Temporary Act of 1983".

Sec. 2. Section 308(a) of the District of Columbia

Administrative Procedure Act, effective October 17, 1981

(D.C. Law 4-41; D.C. Code, sec. 1-1538(a)), is amended by striking the phrase "December 31, 1982" and inserting the phrase "the date of expiration of the District of Columbia Municipal Regulations Publication Temporary Act of 1983" in lieu thereof.

- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
- (b) This act shall expire on the 180th day of its having taken effect, or on the day on which the District of

Columbia Municipal Regulations Publication Act of 1983 (Council Bill 5-151) takes effect, whichever occurs first.
