
NOTICE

D.C. LAW 5-100

"Public Assistance Payments Increase Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-371 on first and second readings, April 30, 1984 and May 15, 1984, respectively. Following the signature of the Mayor on June 6, 1984, this legislation was assigned Act No. 5-141, published in the June 15, 1984 edition of the D.C. Register, (Vol. 31 page 2896) and transmitted to Congress June 8, 1984 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-100, effective August 10, 1984.

D.C. ACT 5 - 141

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUN - 6 1984

To increase the payment levels and standards of assistance for recipients of public assistance.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Public Assistance Payments Increase Act of 1984".

Sec. 2. Section 552 of the District of Columbia Public Assistance Act of 1982, effective April 6, 1982 (D.C. Law 4-101; D.C. Code, sec. 3-205.52), is amended as follows:

(a) Subsection (c) is amended to read as follows:

"(c) The standards of assistance, based on the February, 1983, cost of living index, are set forth in the following table and include basic costs of food, clothing, shelter, household and personal items, certain transportation costs, and life insurance when paid by the Mayor.


(b) Subsection (d) is amended to read as follows:


"(d) The table set forth in this section shall be used for all payments and eligibility determinations made after September 30, 1984."

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973
