"District of Columbia Statehood Constitutional Convention Initiative of 1979 Amendments Temporary Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-414 on first and second readings, April 30, 1984 and May 15, 1984, respectively. Following the signature of the Mayor on June 6, 1984, this legislation was assigned Act No. 5-146, published in the June 22, 1984 edition of the <u>D.C. Register</u>, (Vol. 31 page 3040) and transmitted to Congress June 8, 1984 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-105, effective August 10, 1984.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUN - 6 1984

To amend, on a temporary basis, the District of Columbia Statehood Constitutional Convention Initiative of 1979 to postpone the date of the 1st election for the office of Senator and Representative.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Statehood Constitutional Convention Initiative of 1979 Amendments Temporary Act of 1984".

- Sec. 2. Section 4(d) of the District of Columbia

 Statehood Constitutional Convention Initiative of 1979,

 effective August 14, 1982 (D.C. Law 4-138; D.C. Code, sec.

 1-113(d)), is amended as follows:
- (a) by striking in paragraph (1) the year "1984" wherever it appears and inserting the year "1986" in its place; and
- (b) by striking in the second sentence of paragraph
 (2) the year "1987" and inserting the year "1989" in its place.
- Sec. 3.(a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia

D.C. Code sec. 1-113 (1983 supp Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 180th day of its having taken effect or on the effective date of the District of Columbia Statehood Constitutional Convention Initiative of 1979 Amendments Act of 1984, whichever occurs earlier.
