D.C. LAW 5-107

"Foster Care Goals Act Amendment Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-404 on first and second readings, June 12, 1984 and June 26, 1984, respectively. Following the signature of the Mayor on June 29, 1984, this legislation was assigned Act No. 5-149, published in the July 13, 1984 edition of the <u>D.C. Register</u>, (Vol. 31 page 3388) and transmitted to Congress July 5, 1984 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-107, effective September 26, 1984.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUN 29 1984

To establish goals regarding children in foster care for more than two years for the fiscal years ending on September 30, 1984, and on September 30, 1985.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Foster Care Goals Act Amendment Act of 1984".

Sec. 2. Section 2 of the Foster Care Goals Act of 1983, effective October 8, 1983 (D.C. Law 5-30; D.C. Code, sec. 3-114.1), is amended as follows:

D.C. Code, sec. 3-114.1 (1985 supp.)

- (a) Subsection (a) is amended to read as follows:
- "(a) The number of children who have been in care pursuant to section 11(2) of An Act To establish a Board of Public Welfare in and for the District of Columbia, to determine its functions, and for other purposes, approved March 16, 1926 (44 Stat. 210; D.C. Code, sec. 3-114(a)(2)), for a period of 2 years or more, should be:
- "(1) Not more than 1,283 children as of September 30, 1984; and
- "(2) Not more than 965 children as of September 30, 1985.".
- (b) Subsection (b)(3) is amended by adding the word
 "and" after the semicolon.

- (c) Subsection (b)(4) is repealed.
- (d) Subsection (c) is amended to read as follows:
- "(c) During the fiscal year ending September 30, 1985, the Director of the Department of Human Services
 ("Director") shall report quarterly to the Council of the District of Columbia ("Council") regarding:
- "(1) The total number of children in care, their ages, legal statuses, and goals;
- "(2) The number of children who entered care during the previous quarter (by month), their ages, legal statuses, and the primary reasons they entered care;
- "(3) The number of children who have been in care for 24 months or longer, the number of children who became part of this class during the previous quarter (by month), and the ages and legal statuses of these children; and
- "(4) The number of children who left care during the previous quarter (by month), the number of children in this class who had been in care for 24 months or longer, the ages and legal statuses of these children, and the reasons for their removal from care.".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of a veto by the Mayor, action by the Council to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved

December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
