D.C. LAW 5-133

"District of Columbia Daylight Saving Time Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-427 on first and second readings, September 25, 1984 and October 9, 1984, respectively. Following the signature of the Mayor on October 25, 1984, this legislation was assigned Act No. 5-191, published in the November 16, 1984 edition of the D.C. Register, (Vol. 31 page 5720) and transmitted to Congress January 7, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-133, effective March 13, 1985.

## D.C. ACT 5-191

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## OCT 2 5 1984

To establish daylight saving time in the District of Columbia from the last Sunday in April to the last Sunday in October of each year and to amend and clarify the existing law regarding the adoption of daylight saving time.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "District of Columbia
Daylight Saving Time Act of 1984".

Sec. 2. Section 28-2711 of the District of Columbia Code is amended by striking the present language and substituting the following:

D.C. Code, sec. 28-2711 (1985 supp.)

"The standard time applicable in the District of Columbia shall be advanced by one hour from 2:00 AM on the last Sunday in April of each year until 2:00 AM on the last Sunday in October of each year and this time, known as daylight saving time, shall, during the period of the year for which it is applicable, be the standard time for the District of Columbia.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
