#### D.C. LAW 5-145

"Extension of the Moratorium on Retail Service Station Conversions Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-438 on first and second readings, October 9, 1984 and October 23, 1984, respectively. Following the signature of the Mayor on November 8, 1984, this legislation was assigned Act No. 5-203, published in the November 30, 1984 edition of the D.C. Register, (Vol. 31 page 5975) and transmitted to Congress January 8, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-145, effective March 14, 1985.

## D.C. ACT 5 - 203

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# NOV - 8 1984

To amend the Retail Service Station Act of 1976 to extend the moratorium on the conversion of full service retail service stations to limited service retail service stations and to extend the life of the Gas Station Advisory Board.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Extension of the
Moratorium on Retail Service Station Conversions Act of
1984".

Sec. 2. Sections 5-301(b), (c), and (e)(4) of the Retail Service Station Act of 1976, effective April 19, 1977 (D.C. Law 1-123; D.C. Code, sec. 10-231), are amended by striking the phrase "October 1, 1984" and inserting the phrase "October 1, 1987" in its place.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization

Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
