"District of Columbia Air Pollution Control Act of 1984".

Register, (Vol. 32 page 562) and transmitted to Congress January 23, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia nereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-165, effective March 15, 1985.

JAN 1 1 1985

To enact as title 20 of the District of Columbia Municipal Regulations the air quality control regulations of the District of Columbia and to repeal the District of Columbia Air Pollution Control Act and the Air Quality Control Regulations of the Rules and Regulations of the District of Columbia; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "District of Columbia Air
Pollution Control Act of 1984".

Sec. 2. (a) The District of Columbia Air Pollution Control Act, approved July 30, 1968 (82 Stat. 458; D.C. Code, sec. 6-901 et seq.), is repealed.

(b) The Air Quality Control Regulations of the Rules and Regulations of the District of Columbia, enacted July 7, 1972 (Reg. 72-18; 6A DCRR), is repealed.
