D.C. LAW 5-171

"District of Columbia Uniform Controlled Substance Penalty Amendment Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-443 on first and second readings, December 4, 1984 and December 18, 1984, respectively. Following the signature of the Mayor on January 11, 1985, this legislation was assigned Act No. 5-236, published in the February 8, 1985 edition of the D.C. Register, (Vol. 32 page 730) and transmitted to Congress January 23, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-171, effective March 15, 1985.

D.C. ACT 5 - 236

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JAN 1 1 1985

To amend the District of Columbia Uniform Controlled Substances Act of 1981 to increase the penalties for the manufacture, distribution or possession with intent to manufacture or distribute phencyclidine (PCP) or a phencyclidine immediate precursor; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Uniform Controlled Substance Penalty Amendment Act of 1984".

- Sec. 2. The District of Columbia Uniform Controlled Substances Act of 1981, approved August 5, 1981 (D.C. Law 4-29; D.C. Code, sec. 33-501 et seq.), is amended as follows:
- (a) Section 401 (D.C. Code, sec. 33-541) is amended as follows:

- (1) Subsection (a)(2)(A) is amended to read as follows:
- "(A) a controlled substance classified in Schedule I or II which is a narcotic drug, phencyclidine, or a phencyclidine immediate precursor, is guilty of a crime and upon conviction may be imprisoned for not more than fifteen (15) years, or fined not more than one hundred thousand dollars (\$100,000) or both; except that a person convicted of manufacturing phencyclidine or a phencyclidine immediate

precursor may be imprisoned for not more than 25 years, fined not more than two hundred thousand dollars (\$200,000), or both;";

- (2) Subsection (a)(2)(B) is amended by adding the phrase "except for phencyclidine or a phencyclidine immediate precursor," after the phrase "Schedule I, II, or III,";
- (3) Subsection (b)(2)(A) is amended by adding the phrase ", phencyclidine, or a phencyclidine immediate precursor" after the phrase "Schedule I or II which is a narcotic drug"; and
- (4) Subsection (b)(2)(B) is amended by adding the phrase "except for phencyclidine or a phencyclidine immediate precursor," after the phrase "Schedule I, II, or III,".
- (b) Section 406 (D.C. Code, sec. 33-546) is amended as follows:

- (1) Subsection (a) is amended by adding the phrase ", phencyclidine, or a phencyclidine immediate precursor" after the phrase "which is a narcotic drug"; and
- (2) Subsection (b) is amended by adding the phrase ", except for phencyclidine or a phencyclidine immediate precursor," after the phrase "Schedule I, II, III, IV, or V".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as

provided for in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
