Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-163 on first and second readings, May 10, 1983 and May 24, 1983, respectively. Following the signature of the Mayor on June 9, 1983, this legislation was assigned Act No. 5-40, published in the July 8, 1983 edition of the <u>D.C. Register</u>, (Yol. 30 page 3339) and transmitted to Congress June 13, 1983 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-23, effective August 2, 1983.

I IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, this bill may be cited as the "Day Care Policy Act of Mendment Act of 1983".

- Sec. 11. Payments to child development homes and to caregivers shall be made according to the following seffective October 1, 1982:

- '(a) Full Day Care:
 - "(1) Child development homes: \$9.00 per child per
 - "(2) In-home care:
- "(A) For care during the day, \$4.25 per per day;
- "(B) For care during night hours, \$5.25 per per night;
- (b) Part-time care:
- "(1) Child development homes: \$4.75 per child per

"(2) In-home care:

"(A) Before and after school care, \$2.75 per child per day;

"(B) For night care of less than six (6) hours, \$3.00 per child per night.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
