"Public Postsecondary Education Reorganization Clarification Act of 1983".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-218 on first and second readings, September 20, 1983 and October 4, 1983, respectively. Following the signature of the Mayor on October 21, 1983, this legislation was assigned Act No. 5-73, published in the November 4, 1983 edition of the D.C. Register, (Vol. 30 page 5641) and transmitted to Congress October 26, 1983 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-47, effective February 9, 1984.

To amend the District of Columbia Public Postsecondary Education Reorganization Act to clarify the requirement that the Board of Trustees of the University of the District of Columbia submit a budget each year.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "Public Postsecondary

Education Reorganization Clarification Act of 1983".

Sec. 2. Section 206(d) of the District of Columbia

Public Postsecondary Education Reorganization Act, effective

November 1, 1975 (D.C. Law 1-36; D.C. Code, sec.

31-1516(4)), is amended by striking the phrase "the fiscal year beginning October 1, 1977" and inserting the phrase "each fiscal year" in lieu thereof.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec.
