
NOTICE

D.C. LAW 6-101

"District of Columbia Stadium Act of 1957
Amendment Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-355 on first and second readings, December 17, 1985, and January 14, 1986, respectively. Following the signature of the Mayor on January 28, 1986, this legislation was assigned Act No. 6-129, published in the February 7, 1986, edition of the D.C. Register, (Vol. 33 page 793) and transmitted to Congress on February 3, 1986 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-101, effective March 25, 1986.

D.C. ACT 6 - 129

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JAN 28 1986

To amend the District of Columbia Stadium Act of 1957 to place limitations on the leasing authority of the Armory Board.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Stadium Act of 1957 Amendment Act of 1985".

Sec. 2. Section 5 of the District of Columbia Stadium Act of 1957, approved September 7, 1957 (71 Stat. 619; D.C. Code, sec. 2-324), is amended by designating the existing text as subsection (a) and adding a new subsection (b) to read as follows:

D.C. Code, sec. 2-324 (1986 supp.)

"(b)(1) Subsequent to the transfer of all right, title, and interest in and to the Stadium to the District of Columbia, the management, operation, and maintenance of the stadium shall remain the responsibility of the District of Columbia Armory Board (or successor public agency).

"(2) The District of Columbia Armory Board (or successor public agency) shall not have the authority to


delegate, assign, lease, or contract out for the management, operation, or maintenance of the stadium except to an independent manager or management entity which is not directly or indirectly associated or connected with any tenant of the stadium.

"(3) In the event that both a major, professional league football team and a baseball team are tenants at the stadium, and both are owned by the same individual or entity, such Board or agency shall have the the authority to delegate, assign, lease, or contract the management, operation, or maintenance to such individual or entity.


"(4) Any delegation, assignment, lease or contract that is made or entered into pursuant to this section shall be subject to approval, by resolution, of the Council of the District of Columbia, if that delegation, assignment, lease or contract is either longer than 10 days in duration or greater than \$100,000 in value."

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec.
1-233(c)(1)).
