### D.C. LAW 6-126

"Council of the District of Columbia Compensation Limitation Amendment Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-374 on first and second readings, April 29, 1986, and May 13, 1986, respectively. Following the signature of the Mayor on May 16, 1986, this legislation was assigned Act No. 6-162, published in the May 30, 1986, edition of the D.C. Register, (Vol. 33 page 3211) and transmitted to Congress on May 21, 1986 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-126, effective July 24, 1986.

# D.C. ACT 6 - 162

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# MAY 1 6 1986

To amend the District of Columbia Government Comprehensive Merit Personnel Act of 1978 to remove the limitation on the rate of basic pay of employees of the Council of the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Council of the District of Columbia Compensation Limitation Amendment Act of 1986".

Sec. 2. Section 1103(a)(5) of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective September 16, 1980 (D.C. Law 3-101; D.C. Code, sec. 1-612.3(a)(5)), is repealed.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
