"Rental Housing Act of 1985 Leased Condominiums Clarification Amendment Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-406 on first and second readings, September 23, 1986 and October 7, 1986, respectively. Following the signature of the Mayor on October 16, 1986, this legislation was assigned Act No. 6-216, published in the October 31, 1986, edition of the D.C. Register, (Vol. 33 page 6732) and transmitted to Congress on January 7, 1987 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-167, effective February 24, 1987.

D.C. ACT 6 - 216

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 1 6 1986

To amend the Rental Housing Act of 1985 to clarify the exemption from rent regulation as it relates to condominium rental units and to clarify that certain fines authorized by the act are civil fines.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Rental Housing Act of

1985 Leased Condominiums Clarification Amendment Act of

1986".

Sec. 2. Section 205(a)(3) of the Rental Housing Act of D.C. Code, sec. 45-2515 1985, effective July 17, 1985 (D.C. Law 6-10; D.C. Code, (1987 supp.) sec. 45-2515), is amended by adding a new subparagraph (E) to read as follows:

"(E) For purposes of determining the eligibility of a condominium rental unit for the exemption provided by this paragraph, by section 205(a)(4) of the Rental Housing Act of 1977, effective March 16, 1978 (D.C. Law 2-54; D.C. Code, sec. 45-1642(a)(3)(1978 supp.)), or by section 206(a)(3) of the Rental Housing Act of 1980, effective March 4, 1981 (D.C. Law 3-131; D.C. Code, sec.

45-1516(a)(3)), a housing accommodation shall be the aggregate of the condominium rental units and any other rental units owned by the natural person(s) claiming the exemption.".

Sec. 3. Section 901(b) of the Rental Housing Act of D.C. Code, sec. 45-2591 1985, effective July 17, 1985 (D.C. Law 6-10; D.C. Code, (1987 supp.) sec. 45-2591(b)) is amended by inserting the word "civil" before the word "fine".

Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
