"D.C. Legislature Compensation Comparability Amendment Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-373 on first and second readings, September 23, 1986 and October 21, 1986, respectively. Following the signature of the Mayor on October 30, 1986, this legislation was assigned Act No. 6-224, published in the November 21, 1986, edition of the D.C. Register, (Vol. 33 page 7232) and transmitted to Congress on January 7, 1987 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-175, effective February 24, 1987.

D.C. ACT 6 - 224

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 3 0 1986

To amend the District of Columbia Government Comprehensive Merit Personnel Act of 1978 to provide for an increase in compensation for members of the Council of the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "District of Columbia
Legislature Compensation Comparability Amendment Act of
1986".

- Sec. 2. Section 1109(b) of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code, sec. 1-612.9(b)), is amended to read as follows:
- "(b) The Chairman of the Council shall receive compensation in an amount equivalent to the highest rate of basic pay authorized for an executive agency head, which shall be made in equal and periodic installments. Each member of the Council other than the Chairman shall be paid at an annual rate \$10,000 less than the annual compensation established for the Chairman.".

- Sec. 3. The District of Columbia Government

 Comprehensive Merit Personnel Act of 1978, effective March

 3, 1979 (D.C. Law 2-139; D.C. Code, sec. 1-601.1 et seg.),

 is amended as follows:
- (a) Section 1109(c) (D.C. Code, sec. 1-612.9(c)) is amended by striking the phrase "amounts in subsections (a) and (b) of this section" and inserting in its place the phrase "amount in subsection (a) of this section".
- (b) Section 1110 (D.C. Code, sec. 1-612.10), is amended to read as follows:
- "Sec. 1110. Compensation for Members of the Board of Education.
- "(a) Each member of the District of Columbia
 Board of Education shall receive compensation in the amount
 of \$24,213 per year, which shall be made in equal and
 periodic installments. The President of the Board of
 Education shall receive an additional \$2,500 per year.
- "(b) The compensation amount in subsection (a) of this section shall be adjusted on the 1st day of the 1st pay period beginning on or after October 1st of each year by the percent change, adjusted to the nearest one-tenth of 1%, in the price index published for July of the current year over the price index published for July of the preceding year.
- "(c) For purposes of this section, the term

 "price index" shall mean the Consumer Price Index for All

Urban Consumers (all items Washington, D.C. Standard

Metropolitan Statistical Area average), published bimonthly

by the Bureau of Labor Statistics of the United States

Department of Labor in its official publication, Monthly

Labor Review, or in other official publications.".

Sec. 4. With respect to any Councilmember serving on the Council on the date of enactment of this act, that Councilmember shall continue to receive cost of living and any other compensation increases in accordance with section 1109(c) of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 9, 1979 (D.C. Law 2-139; D.C. Code, sec. 1-612.9(c)), in effect on October 21, 1986, until the Councilmember is eligible for a compensation increase under this act.

Sec. 5. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
