D.C. LAW 6-181

"Temporary Auctioneer License Amendment Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-222 on first and second readings, October 21, 1986 and November 5, 1986, respectively. Following the signature of the Mayor on November 25, 1986, this legislation was assigned Act No. 6-232, published in the December 12, 1986, edition of the D.C. Register, (Vol. 33 page 7664) and transmitted to Congress on January 7, 1987 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-181, effective February 24, 1987.

D.C. ACT 6 - 232

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOV 2 5 1986

To amend An Act Making appropriations to provide for the expenses of the government of the District of Columbia for the fiscal year ending June thirtieth, nineteen hundred and three, and for other purposes to include a provision for a temporary auctioneer license and to set the fee for the license at \$50.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Temporary Auctioneer License Amendment Act of 1986".

- Sec. 2. Paragraph 9 of section 7 of An Act Making

 D.C. Code, sec. 47-2808

 appropriations to provide for the expenses of the government (1987 supp.)

 of the District of Columbia for the fiscal year ending June

 thirtieth, nineteen hundred and three and for other

 purposes, approved July 1, 1902 (32 Stat 623; D.C. Code,

 sec. 47-2808), is amended as follows:
- (a) By designating the first sentence as subsection(a);
- (b) By designating the remainder of the existing text as subsection (c);
 - (c) By adding a new subsection (b) to read as follows:

- "(b) The Mayor may issue a temporary auctioneer license to a person, firm, partnership, association, organization, or corporation engaged in or existing for charitable, benevolent, eleemosynary, humane, religious, philanthropic, recreational, social, educational, civic, fraternal, or other nonprofit purpose and to a citizen-service program established pursuant to section 402 of the District of Columbia Campaign Finance Reform and Conflict of Interest Act, approved August 14, 1974 (88 Stat. 446; D.C. Code, sec. 1-1443). The fee for a temporary auctioneer license shall be \$50. A temporary auctioneer license shall be valid for a period of not more than 7 calender days as specified on the face of the license. Mayor may amend the fee to be charged for a temporary auctioneer license to an amount not to exceed the reasonably estimated cost of performing administrative duties pertaining to the issuance of this license in accordance with the provisions of subchapter I of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1203; D.C. Code, sec. 1-1501 et seq.)."; and
- (d) By adding the phrase "or any holder of a temporary auctioneer license" after the phrase "any licensed auctioneer" in newly designated subsection (c).
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the

Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
