### D.C. LAW 6-189

"D.C. Unemployment Compensation Act Amendments Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-410 on first and second readings, November 5, 1986 and November 18, 1986, respectively. Following the signature of the Mayor on November 25, 1986, this legislation was assigned Act No. 6-240, published in the December 26, 1986, edition of the D.C. Register, (Vol. 33 page 7935) and transmitted to Congress on January 7, 1987 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-189, effective February 24, 1987.

# D.C. ACT 6 - 240

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# NOV 2 5 1986

To amend the District of Columbia Unemployment Compensation Act to avoid a decrease in revenue to the District Unemployment Fund and to conform to federal requirements.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "District of Columbia
Unemployment Compensation Act Amendments Act of 1986".

- Sec. 2. The District of Columbia Unemployment

  Compensation Act, approved August 28, 1935 (49 Stat. 946; (1987 supp.)

  D.C. Code, sec. 46-101 et seq.), is amended as follows:
- (a) Section 3(c)(4)(B)(ii) (D.C. Code, sec.
  46-103(c)(4)(B)(ii)) is amended in the last sentence by
  striking the phrase ", not to exceed 5.4 per centum".
- (b) Section 3(c)(8)(C)(i) (D.C. Code, sec.
  46-103(c)(8)(C)(i)) is amended by striking in the second
  sentence the phrase ", but shall be used solely to fund the
  additional benefits program".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the

Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1).
