

D.C. LAW 6-191

"Board of Zoning Adjustment Confirmation  
Amendment Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-493 on first and second readings, November 5, 1986 and November 18, 1986, respectively. Following the signature of the Mayor on November 25, 1986, this legislation was assigned Act No. 6-242, published in the December 26, 1986, edition of the D.C. Register, (Vol. 33 page 7939a) and transmitted to Congress on January 7, 1987 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-191, effective February 24, 1987.

D.C. ACT 6 - 2 4 2

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOV 2 5 1986

To require Council confirmation of the 3 Mayoral appointments of public members to the Board of Zoning Adjustment.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Board of Zoning Adjustment Confirmation Amendment Act of 1986".

Sec. 2. Section 8 of An Act providing for the zoning of the District of Columbia and the regulation of the location, height, bulk, and uses of buildings and other structures and of the uses of land in the District of Columbia, and for other purposes, effective June 20, 1938 (52 Stat. 799; D.C. Code, sec. 5-424), is amended as follows:

D.C. Code, sec. 5-424 (1987 supp.)

(1) By striking the phrase "five members appointed by the Commissioners of the District of Columbia, namely," in the first sentence;

(2) By adding the phrase "and appointed by the Mayor of the District of Columbia" after the phrase "designated in either case by such Commission" wherever it

appears;

(3) By adding the phrase "appointed by the Mayor of the District of Columbia with the advice and consent of the Council of the District of Columbia" after the phrase "three other members" in the first paragraph; and


(4) By striking wherever it appears the phrase "designated by the Commissioners of the District of Columbia" and inserting the phrase "appointed by the Mayor of the District of Columbia with the advice and consent of the Council of the District of Columbia" in its place.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec.  
1-233(c)(1)).
