D.C. LAW 6-201

"D.C. Uniform Controlled Substances Amendment Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-455 on first and second readings, November 25, 1986 and December 16, 1986, respectively. Following the signature of the Mayor on January 8, 1987, this legislation was assigned Act No. 6-260, published in the January 23, 1987, edition of the D.C. Register, (Vol. 34 page 524) and transmitted to Congress on January 13, 1987 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-201, effective February 28, 1987.

# D.C. ACT 6 - 260

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

### JAN 0 8 1987

To expand the addicts exemption of the mandatory minimum sentences initiative to include cocaine, phencyclidine, and phenmetrazine.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "District of Columbia
Uniform Controlled Substances Amendment Act of 1986".

- Sec. 2. The District of Columbia Uniform Controlled Substances Act of 1981, effective August 5, 1981 (D.C. Law 4-29; D.C. Code, sec. 33-501 et seq.), is amended as follows:
- (a) Section 102(24) (D.C. Code, sec. 33-501(24)) is amended by inserting the phrase "or abusive drug" following the phrase "narcotic drug" wherever it appears.
- (b) Section 102 (D.C. Code, sec. 33-501) is amended by adding a new paragraph (26) to read as follows:
- "(26) "Abusive drug" means any of the following substances, whether produced directly or indirectly by extraction from substances of vegetable origin, or independently by means of chemical synthesis, or by a

D.C. Code, sec 33-501 (1987 supp.) combination of extraction and chemical synthesis:

- "(A) Cocaine, its salts, optical isomers and salts of its isomers;
  - "(B) Phencyclidine (PCP); and
  - "(C) Phenmetrazine and its salts.".
- (c) Section 401(c)(2) (D.C. Code, sec. 33-541(c)(2)) is amended by:

- (1) Adding the phrase "or abusive drug" after the phrase "narcotic drug"; and
- (2) Striking the phrase "such drug" and inserting in its place the phrase "a narcotic drug or an abusive drug".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,
